- The content of this course also includes the settlement process and the infrastructure for services charge settlement. Furthermore, advanced payments and posting documents, created during the settlement process, will be explained in the course.
- Another unit of the course is dedicated to sales-based rent agreements, sales reports, and the sales-based settlement.
- The participants of this course also become familiar with the master data objects and important configuration settings which are necessary to use the mentioned business processes.
- The content of the course S4F72 ('Contracts and Conditions in SAP Contract and Lease Management for SAP S/4HANA') is essential to understand the content of this course.
